Healing Touch is offered as a part of our Complementary Therapies program at Hospice of Saint John. Sessions are available to patients wherever they reside, whether in our inpatient care facility or in homecare. At Hospice of Saint John, Complementary Therapies augment the care provided by the core interdisciplinary team (IDT). The use of Healing Touch, and all Complementary Therapies, is documented as an intervention in patients' plans of care.

Can Patients Request HealingTouch: Yes Patients and family members can request Healing Touch through any member of their care team. An IDT member may also suggest this Complementary Therapy to address a specific symptom. IDT members complete Therapy Referral Forms with the patient's contact information, diagnosis, medical conditions or limitation, and reasons for referral. These referrals are submitted to the Complementary Therapies Team Leader, who coordinates the most appropriate therapist.

Healing Touch Policy and Procedure in Place: Yes

When was HT Implemented and How? In 1999, a Healing Touch practitioner working toward certification proposed doing her practical hours here. She provided sessions to our patients in our inpatient care facility on a daily basis, providing a total of more than 1000 hours here. She also provided treatments and informational sessions for staff. In 2004, a second volunteer began providing Healing Touch for our patients, and our third Healing Touch volunteer came on board in early 2007. Is There Marketing for HT Services: Yes Healing Touch is included in our Complementary Therapies marketing materials, which includes the Complementary Therapies brochure and on our website. Internal marketing is also important for our program. Inservices are regularly provided for staff and volunteers to promote and inform about this available intervention. Healing Touch sessions are provided to staff and volunteers during staff/volunteer appreciation days to increase their familiarity with this intervention, and therefore increase referrals.
